ALA Election

The election closed on Wednesday, April 3. On April 10, the Election Committee will meet at the ALA headquarters to certify the election. Election results will be released following that meeting.

State of America's Libraries

This annual report is now available, highlighting the status of, and trends across, all types of libraries.

Intellectual Freedom Committee (IFC): LBOR Interpretations

ALA's IFC continues to revise various interpretations of the Library Bill of Rights. Recently, two new drafts were disseminated for comment: "Evaluating Library Collections" (adopted in 1973, amended in 1981 and 2008) and "Minors and Internet Activity" (adopted in 2009, amended in 2014). Feedback is requested by April 17 and can be posted in the following two ways:

1. Post feedback on the Google Docs, linked below. The IFC requests that you post comments on the documents, rather than edit the documents directly. To post a comment, select "Insert" in the top menu, and then click "Comment." Comments may be posted anonymously (if you're not signed into a Google account) or publicly (if you're signed into your Google account).

- "Evaluating Library Collections: An Interpretation of the Library Bill of Rights"
- "<u>Minors and Online Activity: An Interpretation of the Library Bill of Rights</u>" (formerly titled "Minors and Internet Activity)

2. Using "track changes," add comments and edits to the Word drafts that I recently circulated via the SCLA listserv. You can email them to Julia Warga (glynnj@kenyon.edu), IFC chair. Let me know if you need them sent to you again. The Intellectual Freedom Committee will make revisions to the drafts in light of suggestions received and plans to distribute the documents to ALA Council prior to ALA Annual Conference in Washington DC. I will distribute the revised drafts to you prior to ALA Annual.
