President

Amber Conger

- Sarah Hood will be leaving and relocating to New Mexico. Thank you to Sarah for her service. Per bylaws, the Executive Committee can appoint a replacement. The Executive Committee unanimously voted to approve Chris Rogers as 2nd VP.
- Chris: "So much of the business we do is not exciting...membership is very important." Hit some targets to increase membership. There is a role for a lot of people in our association. They should become excited about what the library association is doing.
- Please think about who will be taking charge of your group next year. Think about grooming people into leadership positions. John is the nominating committee chair. Think about serving on the Executive Committee. Talking to people one-on-one can be effective. "I pulled in so many people by saying 'hey, you would be great for.'" Everyone in this room is a leader.
- South Carolina's Library Journal, deadline Monday, April 17. Started a few years ago. It is for submissions from SC libraries. It is for any library in SC.
- Conference call with Julie Todaro about library advocacy. Budget proposal 2018 by Trump administration shows cuts for IMLS, innovative bridges of literacy, education association, PBS.... organizations important to libraries. This year we are taking the proposal seriously. ALA approach to fight for funding is earlier and louder. Pushing calls to legislature. Stay engaged with advocacy through the fall. Our focus is ourselves, choose battles carefully.
- Currently National Library Week & recess for congress. Good time to reach out. New fight for libraries page, news coming down from washington office. "We are all responsible for this...we all have to work together and push this out."

Conference Update

Jimmie Epling, 1st Vice President

- Conference is on the website now. Proposal form also online (google form), longer than last years. Exhibitors and sponsors packet online. Changes suggesting more sponsorship opportunities. Super early bird registration for exhibitors (June 1st) \$25 drop from last year. Options to lock in space for 2018 conference. Updating criteria for selection of proposals. Ranking system (1-5).

- Handed out 2017 SCLA Conference Plan. Looking to change poster session times. Friday morning breakfast, unconference (open sessions) a possibility.
- Mystery Masquerade reception. Working with staff. Called *Ripped Page, a murder mystery masquerade*. Mix between the Australian tv show the Librarians, the Office, and murder mystery. Incorporates literary characters. More details to come out after the 29th.

ALA Council I

Sunday January 22

- Executive Director Search- representation of public libraries is needed. Making the conference more sustainable is important.
- Ann K. Symons- Honorary Membership- Voted Yes

NOTES FROM TOWN HALL MEETING

- Cheryl Gorman was facilitator. The town hall was on Facebook live. Advocacy for libraries is needed with the Trump Administration. What is our intention? What are our core values as an association? What is being challenged?
- Some feel that things have not changed very much. Some feel that this is different than what has come before.
- It was remarked that freedom of expression is our core value. We need to find a balance. Funding, copyright, net neutrality, NEH> when do we stand up for these matters?

- We need to come together and unify. If we are not sitting at the table, we do not have a voice. We must revolutionize the model. Strategic plan for advocacy is needed with clear specific agendas. Don't be silent.

ALA APA Council Meeting

- APA Wellness was discussed.

ALA Chapter Councilors Meeting

Chapters Relations Committee- Conduit to ALA Resolution- improved communication between ALA and Chapters.

- **Does your chapter have Core Values?**
- It is remarked to make relationships with legislators, and that many executive directors serve as institutional repositories.
- One chapter is using Zoom as their online meeting software. They said it is reasonably priced and even has a free version. One chapter does not meet in person. They only meet online. Since they do this, they have ground rules for speaking and meeting etiquette.
- Wyoming has hosted a hybrid conference where attendees have the option to join in online. It was recommended, also, that the ALA Chapter Councilor make their own gmail account. Our scholcom group is very interested in open learning and how it can address this issue, and I was hoping we could send a message from either our scholcom group or the SCLA leadership supporting

efforts to reduce textbook cost, and also maybe proposing what might be more effective/sustainable solutions such as open educational resources.

- (a) 'Biological sex' means the physical condition of being male or female, which is stated on a person's birth certificate.
- (b) 'Multiple occupancy bathroom' or 'changing facility' means a facility designed or designated to be used by more than one person at a time where persons may be in various states of undress in the presence of other persons. A multiple occupancy bathroom or changing facility includes, but is not limited to, a restroom, locker room, changing room, or shower room.
- (c) 'Single occupancy bathroom' or 'changing facility' means a facility designed or designated to be used by only one person at a time where students may be in various states of undress. A single occupancy bathroom or changing facility includes, but is not limited to, a single stall restroom designated as unisex or for use based on biological sex.
- (2) A local government or other political subdivision in this State may not enact local laws, ordinances, orders, or other regulations that require a place of public accommodation or a private club or other establishment, not in fact open to the general public, to allow a person to use a multiple occupancy bathroom or changing facility regardless of the person's biological sex. A local law, ordinance, order, or other regulation enacted by a local government to require a person to use a multiple occupancy bathroom or changing facility designated for his biological sex is not a violation of this chapter and does not constitute discrimination based upon a protected category.
- (3) This section does not apply to persons entering a multiple occupancy bathroom or changing facility designated for use by the opposite sex:
- (a) for custodial purposes;
 - (b) for maintenance or inspection purposes;
 - (c) to render medical assistance;
 - (d) to accompany a person in need of medical assistance;
 - (e) for a minor under the age of seventeen who accompanies a person caring for that minor; or
 - (f) that has been temporarily designated for use by that person's biological sex."
- SECTION 2. This act takes effect upon approval by the Governor.

SCLA Awards Committee Recommendations

Processes:

All award nominations should come directly to the Awards Committee rather than some first going to other individual sections, roundtables or committees, i.e. Outstanding Paraprofessional; Intellectual Freedom. This will not only streamline the process, but will remove any conflicts of interest that arise when the leadership of those sections, roundtables, and committees are nominated for the awards that they are meant to judge. Those leaders are often the most active in their specific award areas, and should be able to be nominated without any concerns regarding propriety.

All awards should be offered as appropriate, and not necessarily every year.

Award nominations should be done via web forms rather than paper applications or separate email attachments.

New Awards: (This is just a draft, as all Awards Committee members have not yet given their feedback)

We would like to breathe life back into the Awards process by offering several new awards:

- Student
 - Would honor an SCLA student member who demonstrates dedication to the field, is actively engaged in professional development, and is making important contributions.
 - Would probably encourage a good number of submissions, since it would be a resume builder
 - Would encourage early SCLA involvement by those still in library school

- Innovation
 - Would be given not to an individual, but a team, department, or library branch
 - Would highlight a collaborative effort to make a big spark or positive change in their community or solve a problem in an innovative way (community and results focused, not innovation for the sake of innovation).
 - Would encourage peer learning throughout the organization, as everyone hears about these innovative practices. We could build into the award that the winner will do a public program or webinar for SCLA sometime in the following year.
- New Professional
 - Would honor and encourage those who have already made big contributions to the field, early in their careers.
 - Would require at least one year of service in SC libraries, and five or fewer years of post-MLS library experience.
- Legacy/Hall of Fame
 - To recognize those who have contributed great amounts to their libraries and the profession over their careers.
 - Would be given to those late in their careers – nearing retirement, post-retirement, and could even recognize historical figures
 - Multiple people could be inducted into the Hall of Fame each year, as appropriate.
 - Would be open to both professional librarians and paraprofessionals.
- Intellectual Freedom
 - We used to offer this, but it hasn't been given out in several years
 - Good opportunity to highlight not just library workers, but community members who support libraries' commitment to intellectual freedom (county council, senators, business leaders, etc.).
- "Golden Door of Service"
 - All libraries are (or should be) service oriented. This award would honor an entire library or library branch who goes above and beyond for their community.
 - Nominations would come directly from patrons and community members, similar to the "I Love My Librarian" award
 - Would be a great opportunity for libraries to capture the different ways they are impacting the people in their community, and then show that community support later on.

College and University Section

Leadership Retreat 2/4/2017

The officers of the Section met with members of the Information Literacy Roundtable during the SCLA Leadership Retreat on February 4th for initial discussion of iTeach4, tentatively scheduled for June 2017. Possible locations were discussed: the Midlands

Technical College NE campus was used for iTeach3 and worked well except for the lack of break-out space.

Since much of the value of iTeach is in the collaboration and sharing with colleagues, we felt that this was a requirement for iTeach4. Ease of parking, central location, keynote speaker, conference themes and limiting attendance (depending on space) were also discussed.

iTeach has focused on academic librarianship in the past, but building on the idea that “our seniors are your freshmen,” we recognized the need to reach out to high school media specialists as well. The issue of ‘fake news’ and teaching students to recognize specious sources of information as students and life-long learners was also discussed as a possible theme.

The C&U membership was surveyed last year to gauge interest, location and topics for iTeach3 and preferences for ACRL e-learning webcasts. The 2015/6 survey provided useful information that guided activities for the year, so we wanted to do a similar survey this year.

Membership Survey

As an ACRL chapter, the Section can provide 2 ACLR e-learning webcasts per year at up to 6 sites at no cost to participants. A survey was sent to the C&U membership on 2/23/17 requesting input on a **preferred e-learning webcast**, preferred **topics for iTeach4**, preferred **location for iTeach** and **topic suggestions**. The survey closed on 2/28/17.

The survey was sent to 94 members on the C&U mailing list. Thirty (32%) responses were received between 2/23 – 2/28.

E-learning Webcast

82% of respondents were interested in the e-learning webcast “Essentials of Usability Design for Library Research Guides” vs. “Navigating Without a Chart: Perspectives on the Basics of Acquisitions” (22%).

iTeach4 Topics

28 responses were almost evenly divided on 3 proposed topics: fake news (15), lifelong information literacy (14) and transitioning from high school to college (16).

Location for iTeach4

Columbia, Clemson and Greenville were offered as choices (based on known availability of space) with an option for “other.”

Suggested Topics

Two topics were suggested by two different respondents:

- Diversity and inclusion in Collection Development
- Hybridized teaching/learning strategies

ACRL e-Learning Webcast

Based on survey responses, viewing of the ACRL webcast “Essentials of Usability Design for Library Research Guides” on March 8th was set up at 3 sites (USC, Clemson, Furman) and had a total of 7 attendees. Program Coordinator Shanna Schaffer provided a link to the recording for C&U members after the on-site viewing.

iTeach4

The Section is collaborating with the Information Literacy Roundtable on iTeach4. To date:

- Theme: “Transitions” was selected as it encompasses transitions from high school to college, community colleges to 4-year colleges and college to workplace.
- Keynote: Heather M. Moorefield-Lang from the USC School of Library and Information Science will be the keynote speaker.
- Date: June 14, 2017
- Location: Thomas Cooper Library
- Registration: TBD (to includes lunch)

A call for proposals was sent to the membership of both the Section and Roundtable on 4/4/17 with a submission deadline of May 1st.

Call for Proposals: Transitions and the Roles Libraries Play
