The presentations were on Fresh Leadership, Leading and Managing Others with Kindness, Authority, and Humility and Racial Healing Circles. The session is titled The Critical Race Theory (CRT) digital toolkit, created by Dr. Nicole Cooke and Cearra Harris and aims to dismantle the misconceptions surrounding CRT by making credible resources, media, and teachings accessible to all.
